#### Discussion:

Permits: The EM Fluids team is based out of Ottawa so they aren't aware of specific permits and approvals that may be needed. There are immense considerations that would need to be made around liability.

Timeline: Results may be showcased in as little as two weeks, highly dependent on the overarching issue. First observation may be odor reduction.

GPS: The unit is equipped with a GPS antenna.

Planning: If interested, they would send out a survey to understand issues and gather information available about the lake to design the best strategic approach.

- Upgrades are covered, \$21,00 for the season and you don't own the equipment. Can change if it's multiple years.
